### SECTION 2 — HAZARDS IDENTIFICATION

Hazard class: Acute toxicity, oral (Category 5). May be harmful if swallowed (H303).

Due to a poor shelf life, store in a Flinn Chem-Saf™ bag and then inside a Flinn Saf-Stor™ can. Keep container tightly closed (P233). Use only in a hood or well-ventilated area (P271).
